



Captain's Memorandum

To: All Members

Date: June 16 & 18, 2025

Note: Two Memos were sent out, one to Men's Day participants and one to the rest of the membership. They are documented here:

This message was sent to all Men's Day Participants:

Hi everyone,

As mentioned in a recent [*Captain's Log*](#), we've begun using **Cap Patrol** across the entire club to help monitor and maintain handicap integrity. While the tool is being applied club-wide, a recent analysis focused specifically on Men's Day participants.

What we found was concerning:

More than **20 players in Men's Day** have posted **fewer than 50% of their rounds** so far this season. While some of this may be due to cancelled tee times or non-postable formats, it's also clear that several valid rounds have not been entered into Golf Canada. Others have less egregious numbers but please remember: we expect **all valid rounds** to be entered into Golf Canada in order to participate in Cedar Brae handicap events.

Why it matters:

- This is the **first year we're using Golf Canada handicaps** for Men's Day instead of the old internal system
- Players are responsible for entering their own scores – including Men's Day scores into Golf Canada
- Incomplete posting affects the fairness of competition and puts additional strain on event organizers

To protect the integrity of Men's Day, we may need to take corrective action in the future, especially if incomplete score posting persists.

We expect these numbers to improve quickly. To that end, we'll be **re-running the analysis next week** and following up as needed.

Please take a moment to review your Golf Canada account and ensure your scores are up to date. If you're unsure about

whether a round should be posted or need help with the process, let us know—we're **happy to help!**

Note: The following message was sent to all “golfing” members except Men's Day participants, who had already received a similar notice.

Dear Members,

As mentioned in a recent [Captain's Log](#), we've begun using **Cap Patrol** to help monitor and maintain handicap integrity across the entire club. This system allows us to identify posting patterns and ensure fair play in all handicapped competitions.

A recent review revealed that a concerning number of members participating in club events have posted **fewer than 50% of their rounds** to Golf Canada this season. While some of this may be due to cancellations or non-postable formats, many valid rounds appear to be missing.

If you're entering any handicapped events, including match plays, maintaining an accurate and up-to-date handicap is essential. If you're not participating in handicap events (here at Cedar Brae **or** elsewhere), posting is not required—but for those who are, score tracking is not optional.

If posting activity does not improve in the short term, remedial action will be taken for those with insufficient postings entering handicapped competitions.

We'll be reviewing this again in a week or so. In the meantime, if you're unsure about what should be posted or need help using the Golf Canada app or website, please reach out to the Pro Shop or a [Golf Committee member](#). We're here to help!
